Submit copies of the following documents with your completed application form:

- Proof/certificate from the crematorium services where your pet was cremated.
- A non-refundable application fee of CI\$50.00 (US\$61.00); payable to **Cayman Islands Government***

**Accepted forms of local payments are Cayman Islands and United States cash and cheques drawn on a Cayman Islands bank made payable to the Cayman Islands Government, credit card or debit card – no wire transfers are accepted.*

**Accepted forms of international payments are United States Bank Draft and United States International Money orders, Manager's cheques, and Cashier's cheques, and wire transfers made payable to the Cayman Islands Government – no, personal cheques, credit or debit cards are accepted.*

Your application will be processed and if successful, an import permit will be emailed within three (3) working days.

NB: Permission is required from Department of Environmental Health should you decide to scatter the ashes.
